

# **The 2022 Midterm Election Is Upon Us**

With the 2022 Midterm Election upon us, you should be asking, which candidates really support working families? PDC 30 works hard to help you answer that question, focusing mostly on which candidates offer the best approach to the economy for working families.

One approach to the economy that has <u>never</u> been good for working families is the classic conservative idea often called "trickle-down" economics. This is the idea that reducing taxes and regulations will help the wealthy make more money; they will, in turn, create more jobs, increase pay for workers, and fund charities that reduce the need for publicly-funded services. Advocates of this idea also seek to significantly reduce government spending.

Former Illinois Governor Bruce Rauner's refusal to sign a budget for 793 days – halting state construction and starving universities, agencies, and state-funded services of the resources needed to operate – is an example of how trickledown economics works when its advocates take control of government. The billions of dollars in tax relief the Trump Administration gave to corporations and wealthy individuals, while working families continued to struggle, is another example.

Another approach is the one preferred by organized labor: the belief that increased wages; expanded collective bargaining; strong enforcement and expansion of laws that protect working people; and investments in infrastructure, manufacturing, research and technology, clean energy, and small businesses will lead to greater employment opportunity and better wages for the middle class.

With the 2022 Midterm Election upon us, you should be asking, which candidates really support working families?

Candidates aren't always up-front about which of these ideas they believe in; but it is almost always clear when we consider which public policies they support, and which they don't. On pages 4 and 5, we look at four years of policy accomplishments in Illinois and nationally that show us what public officials can do when they focus on working families.

On the eve of the 2022 Midterms, we urge you to make a plan to support labor-friendly candidates up and down the ballot (see pages 7-11) and support the Workers' Rights Amendment (see page 3). With your vote, you can support family-sustaining

wages; the commitment of public money to rebuilding the public infrastructure that makes our communities strong; and a durable body of rules and regulations designed to protect worker safety, combat worker exploitation, and ensure proper maintenance of public works.

Union voters care about many issues beyond the economy. The good news is, if you vote for candidates who put working families first, PDC 30's endorsed candidates are also leading efforts to support the empowerment of women; guarantee equal pay; promote equal employment opportunity and combat discrimination; tackle drug addiction; treat immigrants humanely; protect communities, schools, and workplaces from violence; defend our essential rights; and preserve our system of democracy.

With your vote for the candidates featured in this issue, you will also be slowing the advance of a form of political extremism that wishes to take us back to a time when good health, quality education, political participation, and family-supporting wages were only possible for the few (while the many struggled).

Your vote is your voice; use it wisely.

# **IL Workers' Rights Amendment: A YES for Labor**

# WRKERS' RIGHTS A M E N D M E N T



The Workers' Rights Amendment (WRA) will update the Illinois constitution to guarantee every Illinoisan has the right to join together with other workers to negotiate for better pay, improved benefits, and safe working conditions. In order for this ballot initiative to pass, it must receive a 60% "Yes" vote in the 2022 Midterm Election held on November 8th.

With the right to collectively bargain enshrined in the Illinois Constitution, our rights as union members will be guaranteed throughout the state. The amended language will stand as an impenetrable barrier between our work and anyone wanting to dismantle the rights of workers. Most importantly, the amendment will make it almost impossible for any future elected officials to attempt to propose so-called "right-to-work" legislation in the state of Illinois.

Through the WRA, nurses will be able to negotiate for the training and staff levels that they need to work safe and properly care for patients; firefighters and police officers will have the safety equipment they need to get home safely; teachers will be able to join together and fight for the supplies they need to provide the best learning environment for students; and construction workers will be able to seek the better pay, safe working conditions, and improved benefits they deserve.

"This amendment will strengthen our communities," shares Beth Penesis, PDC 30's Director of Governmental Affairs. "By protecting our first responders and essential workers, we will create safer workplaces and increase the number of good-paying jobs available throughout the state."

### WHAT WILL THE WORKERS' RIGHTS AMENDMENT DO?

- Helping build an economy that works for every Illinoisan. The WRA will put more money in the pockets of working families by guaranteeing workers' rights to join together to negotiate for pay raises, lifting worker pay to help deal with rising costs.
- Creating great jobs for Illinoisans without college degrees.
   The WRA will increase the number of good-paying jobs available to workers without a college degree, giving every Illinoisan access to a comfortable, middle-class life.
- Protecting workers, on the job and off. The WRA will ensure workers can speak out about dangerous situations that put all Illinoisans at risk without fear of retaliation from their employer.
- Strengthening our communities. The WRA will protect first
  responders like nurses, firefighters, and EMTs, giving the
  people who put their lives on the line to protect us the training
  and safety equipment they need to get home safely each day.

# PDC 30-Endorsed Candidates Accomplish Much for Organized Labor

Considering PDC 30's endorsed candidates, you might be asking, what have these candidates done for organized labor? Consider these accomplishments and the vital role labor-friendly candidates played in making them happen.

# CONSTRUCTION WORK AND INFRASTRUCTURE IN ILLINOIS

Four years ago, incoming Governor J.B. Pritzker immediately shifted state priorities in favor of working families. "In my first 24 hours as governor, I issued an executive order requiring project labor agreements on state funded projects," he reminded those assembled at the 2022 IUPAT Central Regional Conference on August 31, 2022. "Today, Illinois ranks first in the nation for a total number of over 800 PLAs, more than all other states combined."

That was just the start. Within his first year in office, working with lawmakers on both sides of the aisle, Pritzker delivered the largest infrastructure program in the nation. The **Rebuild Illinois capital plan** is a \$45 billion investment in growing jobs and building a vibrant Illinois economy. "Today," Pritzker told the IUPAT audience, "we're rebuilding bridges, roads, and upgrading water towers in every corner of Illinois, and putting hundreds of skilled painters to work in the process."

When the COVID-19 pandemic hit, Pritzker worked with construction trade unions to ensure Illinois' construction workers were deemed "essential." And, after two consecutive months of rising unemployment brought on by COVID-19, the Illinois Department of Labor took the positive step of activating the Illinois Preference Act on July 1, 2020. Activation of the Act meant that until high unemployment subsided, 90% of workers on new and ongoing public works projects throughout the state must live in Illinois.

More specific to painting and allied trades, on August 9, 2019, Pritzker signed into law amendments to the Illinois

Environmental Protection Act (HB 137).

The amendments led to the adoption of rules and standards regarding corrosion mitigation and prevention work, requiring the use of certified protective coatings workers trained in the highly specialized equipment, products, and methods of corrosion work. These new provisions are at the center of PDC 30's advocacy efforts to influence who wins bids to work on local water systems, such as water towers.

More recently, the legislature and Pritzker produced a bill that closes wage theft loopholes that were benefiting non-union construction contractors. On June 10, 2022, House Bill 5412 and its trailer bill, House Bill 4600, were signed into law. Both bills amend the Illinois Wage Payment and Collection Act (WPCA) to make primary contractors, in certain situations, liable for any debt owed by a subcontractor – at any tier. This puts primary contractors on the hook for wage theft committed by their subcontractors.

Like all legislation signed by the Governor, its arrival on his desk first requires adoption by a majority of Illinois legislators.

Amendments to the WPCA were championed in the Illinois Senate by a longtime ally of PDC 30 and labor unions in Illinois, Cristina Castro, who said of the measure: "This measure will ensure that the hardworking individuals who are employed by subcontractors receive fair compensation should that subcontractor fail to pay them."

### WAGES AND THE PREVAILING WAGE

In addition to stopping the systematic assault on collective bargaining in Illinois, Pritzker and pro-labor legislators in Springfield raised the minimum wage to a living wage for all Illinois workers. Signed into law in 2019, the legislation paved the way to a significant increase of Illinois' minimum wage. Since that legislation was signed, there have been four increases in the minimum wage. On January 1st of this year, the state's minimum wage went up to \$12 an hour. The rate will continue to increase on January 1st each year until it hits \$15 per hour in 2025.

Construction trade unions are also grateful to Illinois Comptroller Susana Mendoza for her creative use of her authority to enhance enforcement of the Illinois Prevailing Wage Act. In August of 2019, Mendoza, who pays the State's bills and monitors State funds, issued an Executive Order putting companies on notice that

her office would hold up state payments to companies that violated the Prevailing Wage Act by underpaying workers.

# NATIONAL INFRASTRUCTURE AND THE ECONOMY

PDC 30's endorsed federal candidates, including incumbent House members and U.S. Senator Tammy Duckworth (see page 7), can claim perfect, if not near-perfect, voting records on legislation supported by organized labor. Several accomplishments should be mentioned, beginning with the American Rescue Plan Act of 2021. This measure provided \$1.9 trillion in emergency assistance to the American people during the unprecedented COVID-19 crisis.

When Joe Biden won the presidency, he was expected to seek passage of a multiemployer pension plan bailout and restructuring plan, a key legislative priority for labor unions. The American Rescue Plan delivered on this promise with "Special Financial Assistance Program for Financially Troubled Multiemployer Plans," a long-awaited program to enhance retirement security for millions of union members by providing eligible multiemployer defined benefit pension plans with special financial assistance.

While PDC 30's Pension Plan is not in need of this assistance, roughly 1.3 million union members participate in plans that are dangerously underfunded. "All of us know somebody who worked all their life, did all the right things, worked for a company that set them on a pension, and then that company went bankrupt and the pension got wiped out," U.S. House member Sean Casten recently said about the new financial assistance.

After decades of delay and infrastructure decline, a bipartisan infrastructure bill the Infrastructure Investment & Jobs Act - emerged from the U.S. House and Senate, and was signed into law by President Biden, in late 2021. All PDC 30endorsed candidates for the U.S. House and Senate supported the \$1 trillion investment in roads, bridges, transit, rail, climate change mitigation, clean drinking water, and more. The bill also includes labor standards guaranteeing that the jobs created have family-supporting wages, as well as "buy America" provisions that will bolster U.S. manufacturing. The Act will result in Illinois receiving at least an

additional \$15.8 billion to pursue additional critical investments in infrastructure, including bridges and water infrastructure.

Federal lawmakers took significant action to address rising costs, climate challenges, and escalating prescription drug costs in the **Inflation Reduction Act**, historic legislation that will cut costs for Illinois families, while paying for itself through a minimum tax rate for large corporations and reforms targeting tax fraud. The Act also expands Affordable Care Act subsidies, which will protect nearly 300,000 people in Illinois from loss of health coverage or premium hikes.

### **WORKFORCE DEVELOPMENT**

It's not every day (or year, or decade) that PDC 30 can point to a direct link between legislation sponsored by a member of the U.S. Congress and career success of individuals entering the Illinois finishing trades. U.S. House member Bill Foster made that possible in 2022, when he returned from Washington having successfully acquired funding to support a new pre-apprenticeship program for industrial painting.

"Not only will the Infrastructure Investment and Jobs Act fix the potholes in our roads and make it easier to get to work, but it will create jobs and grow our economy. I'm proud that this bill invests billions of dollars into revitalizing Illinois' infrastructure."

Funding for the Industrial Painting Preapprenticeship (or IPP) was included in the Consolidated Appropriations Act, 2022 (signed into law by President Biden on March 15, 2022). The IPP brings together the three apprenticeship programs in Illinois affiliated with the IUPAT – 14, 30, and 58 – to prepare the next generation of Illinois' industrial painters.

### **WORKERS' RIGHTS AMENDMENT**

As the Workers' Rights Amendment (WRA) made its way onto the November Ballot (see page 3), each of the incumbent Illinois Senate and House members endorsed by PDC 30 voted in favor of it. Of the WRA, Illinois Governor J.B. Pritzker told the attendees of the IUPAT Central

Regional Conference in August: "I'm proud to stand with the thousands of Illinois IUPAT members to fight for its passage."

Since its adoption, corporate and politically conservative interest groups have worked hard to keep it off the November ballot, and some public officials fought these forces directly. Comptroller Susana Mendoza, for example, was named in a lawsuit to keep the WRA off the ballot (along with members of the Illinois Board of Elections); they fought the effort and won in late August, keeping the measure on the ballot.

# **Alexi Giannoulias for Illinois Secretary of State**



PDC 30 was one of the first union organizations to endorse Alexi Giannoulias for Illinois Secretary of State in the Primary Election earlier this summer; he won the Primary and now has our full support heading into the Midterm Election on November 8th.

"Building and construction trades see a lot to like about Alexi," says Beth Penesis, PDC 30's Director of Governmental Affairs. "He's got experience leading an executive branch office and a track record of keeping working families at the center of his thinking when setting policies and reforming processes. We've learned a lot in recent years how necessary experienced pro-labor leaders are to protecting the gains won by Illinois' labor unions."

"Something we really like about Alexi is that he listens," says Ryan Anderson, PDC 30's Business Manager/Secretary-Treasurer. "He engages us directly with questions about what we can do together to help Illinois' communities thrive."

PDC 30's endorsement also recognizes Alexi's commitment to restoring trust between government and the people.

"I'm honored and incredibly excited to have earned the endorsement of PDC 30 and I will stand strong with their members who comprise their nine local unions in suburban Chicago and in Northern and Central Illinois," Alexi said. "I will advocate for them and fight for all Illinois workers who want nothing more than the opportunity to earn a fair wage, receive affordable healthcare and build a better life for their families. I will amplify their voices in Springfield and ensure they get heard."

# **Ted Penesis for Kane County Board, District 16**



Over the last few months, Ted Penesis has knocked on hundreds of doors to learn what really matters to people. On November 8th, he will compete in the General Election for the 16th District seat on the Kane County Board.

If you ask Ted why he is running for a seat on the Kane County Board, he will sum it all into one sentence: "I want to put Kane County on the side of working families."

Born into a union family, Ted is a driven and accomplished professional with extensive experience in both the public and private sector, including his most recent tenure as Director of Community Outreach at the Illinois Department of Natural Resources. But his longtime involvement and partnership with PDC 30 and organized labor make him an easy

endorsement. Throughout his professional career working across multiple industries, including governmental institutions and recreational agencies, Ted has always been true to the needs of working families and the middle class.

"The county has a responsibility to cut costs where it can, to help working families succeed," says Ted. "That means holding the line on taxes, and fighting every day to put Kane County on the side of people like us – the ones who have to pick up the tab."

One might wonder, what can a county board member do for working people? As a strong labor ally and close friend to PDC 30, Ted can do a lot. His understanding of how local government decisions effect union households, for example, will influence important decisions on such matters as the annual certification of prevailing wages.

Local government bodies must annually certify and publish the standard wages to be paid in a geographical region for construction work – this standard includes

amounts required to provide health and retirement benefits, and to provide trade-specific training. Construction contractors are then required to pay the certified wage for public work. This certification is accomplished in a resolution passed each year by local governmental bodies.

As a Kane County Board member, Ted is committed to advocating for these and other requirements that are deeply important to union members living and working in Kane County.

"We will be lucky to have a strong advocate on this local board to protect the gains for working people and other issues important to middle class residents," says Ryan Anderson, PDC 30 Business Manager/Secretary-Treasurer.

Ted, a Democrat, will be on the General Election ballot for residents of District 16 of Kane County. With vast experience as a leader and a record of involvement within the community, Ted is a strong choice for union voters this election.



# JOHN PENNEY RUNNING UNCONTESTED IN WINNEBAGO COUNTY BOARD RACE

John Penney (R) is a lifelong resident of Rockford with an impressive record of volunteer service within his community. He has been a proud union member of PDC 30 for over 20 years and now serves as IUPAT General Representative.
